2. <u>Discussion of the California Maritime Academy proposal to provide training for the combination course/bridge resource management for pilots as part of an inter-agency agreement. Possible recommendation to the Board to contract with CMA for the combination course continuing education training using an inter-agency agreement.</u>

Chairman Roberts invited Jim Burns of the California Maritime Academy (CMA), to speak on their proposal to provide continuing education to the San Francisco Bar Pilots (SFBP) via the Combination Course training. Mr. Burns described the resources available to CMA, its highly experienced and trained staff, and the advanced simulation facilities at their disposal.

Mr. Cronin enquired about other facilities on the west coast. Executive Director Garfinkle reported that the State of California has a strong bias toward inter-agency agreements. Mr. Garfinkle assured him that the proposal was vetted to ensure propriety.

Other Committee members asked questions about the curriculum, facilities and accommodations, which Mr. Burns duly answered. He spoke about CMA's commitment to being the top institution of its kind in the country as well as its staff's commitment to maintaining the high standards set for the continuing education combination course.

**MOTION:** RADM Johnston moved to accept the proposal by the California Maritime Academy to host the BOPC continuing education combination course. John Cronin seconded the motion

**ACTION:** The motion passed unanimously.

3. <u>Discussion and review of existing training in the use of "PilotMate" by ARINC, which utilizes differential global positioning system (GPS) information. Possible recommendation to Board to contract for additional training.</u>

Executive Director Garfinkle reported that a PilotMate training had taken place on July 11, 2012 and that there are presently 24 pilots who have been trained on the equipment. Commissioner Roberts noted that beyond the training, a pilot has to use the equipment in a practical setting to get comfortable with it.
