4. Review of Navigation Technology Surcharge rate (currently at \$40/move), and the revenues, expenditures and reserve balance. Recommendation to the Board to adjust the Navigation Technology Surcharge rate, if warranted. (Ray Paetzold, San Francisco Bar Pilots Business Manager-General Counsel)

Mr. Paetzold reported the following:

- The Navigation Technology Surcharge rate became effective July 1, 2017, and was set by the Board at \$40/move at that time.
- The navigation technology loan interest payments made from July 1, 2019, to September 1, 2019, totaled \$5,340.13.
- Loan principal payments made from July 1, 2019 to September 1, 2019, totaled \$72,621.78.
- Total loan payments made from July 1, 2019 to September 1, 2019, totaled \$77,961.91.
- As of September 1, 2019, the navigation technology loan balance was \$361,523.28.
- The prime interest rate on the navigation technology loan is 5.25%, that the amortization schedule will vary with the prime rate and any further reductions of principal, and that it is too early to determine if the total interest owed on the loan will exceed the amount that was previously authorized by the Board.
- The projected monthly navigation technology surcharge revenue with the rate \$40/move based on 725 moves/month is approximately \$29,000.00 per month.
- Debt service is expected to be approximately \$25,000 per month until the second quarter of 2020.
- He recommended maintaining the Navigation Technology Surcharge rate at \$40/move, to be reviewed again in the fourth quarter of 2019.
