The Ad Hoc Committee on Pilot Diversity (Committee) of the Board of Pilot Commissioners for the Bays of San Francisco, San Pablo, and Suisun (Board) will meet on Tuesday, August 3, 2021, at 9:30 a.m. The agenda items are listed below.

**\* Due to the Governor's proclamation of a State of Emergency resulting from the threat of COVID-19, and pursuant to the Governor Newsom's [Executive Order N-29-20](#), issued March 17, 2020, certain provisions of the Bagley-Keene Act are suspended or waived during the declared State of Emergency.
