COMMITTEE MEETING**

The Selection Appeal Committee of the Board of Pilot Commissioners for the Bays of San Francisco, San Pablo, and Suisun will meet on Tuesday, August 9, 2022, at 1:30 p.m. (Pacific Daylight Time).

**Based on the recent changes to the Bagley Keene Open Meeting Act (Government Code section 11123) by the passage of SB 189, the Board meeting will resume being only remotely accessible.
