Comments by Assembly member Timothy Grayson on Assembly Bill No. 2056, concerning pilotage rates and pilot boat surcharge, which was signed by Governor Newsom on September 29, 2022.

President Hayes-White thanked Assembly Member Grayson and all the parties who collaborated in passing Assembly Bill No. 2056. She introduced Assembly Member Grayson who thanked the Commission and staff, San Francisco Bar Pilots (SFBP), and all other stakeholders for collaborating and carrying the bill through for the Governor's signature, with the goal to maintain the safety of the waterways, keeping the supply chain working, and delivering services to the entire Bay Area.

7. Directors' Report (Executive Director Garfinkle)

A) Correspondence and activities since the Board meeting held on September 22, 2022.

Executive Director Garfinkle reported on the following:

- On September 23, 2022, Board staff received the Pacific Merchant Shipping Association (PMSA) *West Coast Trade Report* for September 2022.
- Also, on September 23, 2022, he and members of the Board staff met with the California Department of Transportation (Caltrans) Information Technology (IT) team members to discuss initiating a enterprise database solution for digitizing the Board's record keeping. This will likely be a multi-year project, with the planning and budgeting phase to begin soon.
- On September 26, 2022, Board staff received the United States Coast Guard (USCG) Fleet Week Public Notice on restricted areas on the bay during the Parade of Ships and the Blue Angels airshow.
- On September 26, 2022, he received an invitation to the USCG Sector San Francisco Vessel Transportation Service's 50th Anniversary event, to be held on November 3, 2022.
- On September 28, 2022, he provided SFBP with the Surcharge Rate Letter for the fourth quarter of 2022.
- On September 29, 2022, BOPC staff was notified by Artelia, the company the runs the Port Revel Manned Model facility, that 2023 spots were filling up fast, and offered us open training opportunities for four sessions. At the time, we still did not have a contract with Artelia, but, requested them to hold three one-week sessions in 2023.
- On September 29, 2022, Board staff received copies of the surveys for PV PITTSBURG and PV GOLDEN GATE.
- On September 29, 2022, AB 2056 was signed by the Governor.
- On September 30, 2022, he attended the Selection Appeal Committee meeting.
- Also, on September 30, 2022, Board staff was notified that Tamie McGowen will be
 joining CalSTA as the Acting Deputy Secretary for Communications. Ms. McGowen
 was previously the Assistant Director of Public Affairs at Caltrans for the past 15

B) Report on pilot licensing matters since the Board meeting held on September 22, 2022.

Executive Director Garfinkle reported that since the September Board meeting, the Board has issued a license renewal to Captain Lowe.

C) Report on Board surcharges.

The Board surcharges collected for September 2022 totaled \$275,756.80 comprising the following surcharge amounts:

D) Report of Pension Fiduciary.

As of October 1, 2022, there are 84 pensioners.

The pension surcharge rate was set for the third quarter of 2022 at \$0.06091, based on a 12-month tonnage lookback period that ran from April 2021 through March 2022.

With the pension surcharge rate set at 0.06091, and the tonnage for September at 20,122,845, the resulting collection totaled \$1,225,682.40, reduced by a true-up payment

of \$61,796.07, resulting in target distributions of \$1,163,886.33. The target payments were \$1,158,023.82, resulting in a variance of \$5,862.51 over target (compared to the August 2022 variance of \$12,593.10 over target). Administrative costs for August were \$2,401.85. The total distribution for August was \$1,223,280.55.

The COLA last increase to the pension was April 1, 2020. According to Harbors and Navigation Code 1167, the Board must review the pension whenever there is a 12% change in the CPI or every three years. Board staff checked the CPI percentage change on October 11, 2022, and found a 10.728% change from December 2020, to August 2022.

E) Report on outstanding requirements of Board actions in response to Board determination and direction on Incident Review Committee reports.

There was nothing to report.

F) Report on legislative activities and contractual matters.

Staff Services Manager I Wong reported that AB 2056 was signed by the Governor on September 29, 2022.

Regarding the Report on Contractual Matters, Staff Services Manager I Wong stated that Board staff received notification that the NCB Justification was approved by DGS and is pending Artelia's signature.

8. Port Agent's Report (Port Agent Carlier)

A) Monthly report on San Francisco Bar Pilots (SFBP) pilot availability and absences.

Port Agent Carlier reported that the following pilots were absent for medical reasons (AFMR):

Port Agent Carlier reported that the SFBP continually monitors the dispatch list for possible 12-hour minimum rest period (MRP) exceptions. For any potential exception that is likely to result in a rest period of less than 10 hours, SFPB will ensure that mitigating measures are enacted. Mitigating measures include, but are not limited to, suspending continuing professional development protocols, cancelling scheduled meetings, cancelling previously granted compensation time off request, suspending SFBP internal working rules, or calling in off-watch pilots.

There are currently 50 licensed pilots.

In September, there were 8 MRP exceptions, with the shortest rest period being 10.1 hours.

B) Monthly report on SFBP ship piloting business activity.

For September 2022, there were normal operations for P/V CALIFORNIA, P/V DRAKE, and P/V SAN FRANCISCO. P/V GOLDEN GATE was offline from September 9, 2022 through September 16, 2022, due to a bent propeller. P/V PITTSBURG was laid up starting on March 9, 2022.

Billed vessel moves for September 2022 were as follows:

•	Bar crossings	388 moves
•	Bay Moves	122 moves
•	River Moves	51 moves
•	Total Moves:	561 moves
•	Gross Registered Tons (GRT):	20.1 million

When comparing 2022 vessel move data with the same period in 2021, total moves were down 3.6%, and GRT was down 4.2%.

- The eight active trainees include Adams, Barnum, Burns, Meyer, Olmsted, Pascucci, Sappington, and Snapp. The trainee's range of time in the program spans from 6 months to 35 months.
- Adams, Olmstead, Barnum, Sappington, and Snapp have First Class Pilotage endorsement for unlimited tonnage upon San Francisco Bay issued by the Coast Guard on their federal license's.
- Adams, Olmstead, Barnum, Sappington, and Snapp are handling in all areas. Adams remains on probation and continues to work on consistency in his piloting.
- Burns, Meyer, and Pascucci are acquiring route trips and handling or part handling vessels in all areas.
- In closed session, all trainees were individually interviewed and counseled on their progress in the training program. Most of the trainees are meeting the recommended benchmarks and are progressing at their own rates.
- The next PEC meeting is scheduled for November 16, 2022 at 7:30 a.m. in the Board office.

Executive Director Garfinkle reported that there were no incidents since the last meeting.

12. Significant Port Safety and Security Cases Report (Executive Director Garfinkle)
Report on marine casualties, navigational safety, and significant incident management
cases relevant to the Board as reported by the U.S. Coast Guard in its Prevention /
Response – San Francisco Harbor Safety Statistics report.

Executive Director Garfinkle states that these reports are from the U.S. Coast Guard via the Harbor Safety Committee meeting. He reported two items of interest:

- A foreign flagged containership experienced a loss of propulsion while transiting from Anchorage 9 to Richmond, CA was caused by fuel switching. A setting on the Main Engine was not properly changed when switching from LSFO to LSMGO, causing the vessel to lose propulsion during astern propulsion. Case closed.
- A foreign flagged containership experienced a loss of propulsion while outbound from the Port of Oakland. The propulsion failure was due to software problems not attributed to fuel switching. Case closed.
- 13. Pilot Trainee Training Program Selection Examination (Executive Director Garfinkle)
 - A) Report on the 2022 Pilot Trainee Training Program Selection Examination and presentation of the Pilot Trainee Validation Report, prepared by California Department of Human Resources (CalHR), Selection Services Program.

Executive Director Garfinkle presented the exam validation report to the Board and noted that there were 38 candidates who applied to take the exam, 37 actually took the exam, 27 passed the written exam and qualified for the simulator exam and ten candidates were successful on the simulator portion. He congratulated the ten successful candidates from the June 2022 exam.

16. Report on shipping activity regionally and within the Board's jurisdiction (Captain McIntyre)

Captain McIntyre reported that the shipping traffic continued to be down in volume since 2020-2021. Congestion in SoCal has been eliminated due to lower volumes and staged arrivals. Cargo diversions are an ongoing concern. Pacific Maritime Association (PMA)/International Longshore and Warehouse Union (ILWU) contract negotiations are ongoing. A strong dollar means less exports, and typically would result in higher imports, but due to inflationary pressures and softening market demand appears to translate to less cargo. There is no increase in traffic expected in the short term. Ship size increases meant less vessel moves even thought there was greater tonnage.

17. Discussion of Assembly Bill 2056 progress and implementation. (Captain McIntyre)

Captain McIntyre stated that on October 1, 2022, San Francisco Bar Pilots had raised the rates on bay and river moves, and made changes on miscellaneous rates which will bring in additional revenue. Representatives of SFBP and PMSA met with Executive Director Garfinkle and Acting Assistant Director Cristia-Plant to discuss administrative procedures that may facilitate implementation of the new surcharges. Regarding the rate setting process, material from the Ad Hoc Committee to Review the Pilotage Rate Setting Process was incorporated into the statute, however some small amount of rulemaking still needs to occur, as the current regulations do not align with the new statute.

18. Public comment on matters not on the agenda. (President Hayes-White)

Former Commissioner Prada recognized and thanked the Board for guidance and support and welcomes the Board members to reach out to him if needed.
