We want to be sure you know that if you are faced with an unsafe pilot transfer arrangement, the BPC will support your decision to refuse boarding until a safe transfer arrangement can be made. You might wish to keep a copy of this letter to present to a ship's captain should the transfer arrangement not be satisfactory.

Page 3 contains an explicit statement from the shipping industry that "pilots have the right to decline to board a vessel offering defective boarding arrangements...".

Please report any unsafe arrangements using the Puget Sound Pilots & Port of Grays Harbor Pilotage Pilot's Report of Non-Compliant Transfer Arrangement. The BPC Pilot Safety Committee reviews and compiles all these reports into a comprehensive document each quarter. These are available from BPC staff.

Remember, the BPC supports your decision to require compliant and safe transfers during your assignments.
